### REFUSE AND RECYCLING COLLECTIONS

### For flats

Refuse is collected twice a week on a Tuesday and Friday.

Recycling is collected once every fortnight on a Friday.

All refuse and recycling must be in the bins in the communal bin store by 07:00 on the day of collection.

### For houses

Refuse and recycling is collected once every fortnight alternately on a Friday (one week refuse is collected, the following week recycling is collected).

All waste and recycling must be on your boundary by 7:00 on the day of collection.

Please do not park on the roadway entrance as you drive into the main parking areas, as this will block access for the Refuse/Emergency Service Vehicles

If the refuse trucks cannot get access to the bin enclosures, refuse will not be collected, this is a potential health and safety risk due to the build-up of waste.

Residents are permitted to park at the discretion of Epping Forest District Council, if vehicles cause a nuisance we are able to consider withdrawing permission for individuals to park on the estate.

### DOG FOULING

The Council have recently received a lot of complaints about dog fouling around the Limes Estate. In particular around the children's play area and the playing fields near to the red block. Aside from the nuisance factor, there are health risks associated with dog fouling, especially to children, from the bacteria and unpleasant parasites that can be present.

The Council has a Public Spaces Protection Order (PSPO) in place across the District that makes it an offence to allow a dog to foul on open land to which the public have access, including parks, footpaths and any part of the highway. Anyone responsible for a dog must clear up any fouling. Failure to do so could result in legal action being taken.

The Environment and Neighbourhoods Team investigate complaints and can issue fixed penalty notices of £100 or prosecute offenders, which could result in a court fine of up to £1000.

There are a number of dog waste bins on the estate, which are regularly emptied by our waste contractor. In areas where there is no dog waste bin, a normal litter bin can be used if the waste is property wrapped in a plastic bag.

### LIFT REPLACEMENT PROGRAMME



The Council is undertaking a major works programme to replace the old and obsolete system components that are installed in the

9-passenger lifts situated in the 9 blocks of flats which make up the Red, Green and Yellow blocks at Copperfield and Limes Avenue.

The programme of works will be carried out on a block by block basis over the current financial year and works commenced on Red block in April 2018. It is estimated that the works for each lift will take seven weeks to complete.

These works are essential and are required to ensure a safe and uninterrupted future service of the passenger lifts. The contractor appointed for the work is:

The contractor can be contacted during working hours which are between 8:00 and 17:00 hours, weekdays on the above telephone number. Out of hours emergencies should be reported to Epping Forest District Council on 01992 564000.

Please be aware that there will be some disruption while these works are being carried out and sections of the main stairwell and an area of the car park will be temporarily closed off while contractors are on site. Please note that there is an alternative stairwell which must be used at these times.

There is a charge based on the number of items with at 50% concession for residents aged over 60

•	1 to 3 items cost	standard £24.50	aged over 60 years £12.25
•	4 to 7 items cost	standard £36.50	aged over 60 years £18.25
•	8 to 10 items cost	standard £48.00	aged over 60 years £24.00
•	11 to 15 items cost	standard £61.00	aged over 60 years £30.50

Items that are larger than 2 metres wide x 2.5 metres high can only be accepted if they are dismantled and will be charged as two items.

All items registered for collection must be put out for collection at the boundary of the property nearest the road side by **07:00** on the day of collection.

The only items that will be taken for collection will be those recorded at the time of booking.

We **DO NOT** accept the following items for special collection:

- No carpet or underlay, pianos or marble worktops, fixtures, fittings or building materials.
- No hazardous waste and no chemical waste, paint or any other liquid substances
