#### Why has this Final Notice been sent?

This Final Notice has been issued because our records show that you have missed one or more of your payments.

#### What should I do next?

You need to do one of the following:

1) Pay the amount outstanding, as detailed in Final Notice issued. If you choose to pay by debit or credit card over the phone, you can call 24 hours a day. The number to call is 01992 564600. # How can I avoid this happening again?

Make sure your instalments are paid by the date due or make future payments by Direct Debit. The Council offers several payment options to people paying by Direct Debit and it is the easiest way to pay. You can set up a Direct Debit and manage your Council Tax online via our portal where you can view bills, check transactions/instalments & balances. ## What if I believe I have paid the sum due?

If you have paid the amount on the Final Notice, within the past few days, it is possible that your payment will have crossed in the post. In this case, please ignore this notice and accept our apologies. **Please attach your payment receipts.** This will help us to check your payments and answer your questions more quickly.

### What if I have applied for Local Council Tax Support?

Until your support is granted, you must pay the instalments given with your bill. If you receive benefit later, it will be taken away from the amount you owe. You will receive a new bill, or a refund if you have overpaid. Any enquiries please Email benefits@eppingforestdc.gov.uk

If you are on low income and are not already receiving Council Tax Support, you can check whether you can claim and make an application online. # Are there any other ways of reducing my bill?

Yes. There various discounts and exemptions which you may be able to claim.

A property may be exempt from Council Tax. For the time the property is exempt, no Council Tax is charged. Exemptions can be for a set time or stay exempt until circumstances change. If you are eligible you can get a discount on your Council Tax bill. If your application is successful, we will revise your Council Tax bill and refund any overpaid amounts. Local Council Tax Support (LCTS) is provided to people on low incomes to help with their Council Tax bill. You can apply if you are liable for Council Tax at the home you live in. What you get depends on

- Where you live each council runs its own scheme
- The make up your household e.g. children and other adults
- The income of you and any partner
- The capital owned by you and any partner

# What if I have appealed against my valuation banding?
